

IMPORTANT INFORMATION- Roadside Assistance Benefits

You currently have a roadside assistance package offered through the Blue Sky RV Motor Club. The benefits under this roadside assistance program are separate from the Blue Sky RV Insurance Program insurance policy that you purchased. **THE PURCHASE OF THIS ROADSIDE ASSISTANCE BENEFIT IS TOTALLY OPTIONAL-** you are not required to purchase the roadside assistance benefit to obtain an insurance policy through the Blue Sky RV Insurance Program.

Your annual cost to renew the roadside assistance benefit is \$52. Because you currently have this benefit, this cost is included in the amount due shown on the renewal invoice. However, because the benefits provided by the roadside assistance package are not part of the insurance policy, the cost to renew the roadside assistance package is not displayed on the insurance policy Declarations Page that is enclosed.

The roadside assistance package you have purchased provides an unlimited towing benefit under the roadside assistance and extends to all vehicles in your household. Some additional benefits that are provided under this program are listed below.

24-HOUR EMERGENCY ROAD SERVICE – Service Contract

A. Emergency Road Service: When members' auto is disabled, a service vehicle will be dispatched to your aid. All road services are paid for in total by your membership. Your membership will cover only 1 service in a 72-hour period and is limited to 5 services per membership term. If you obtain services on your own without contacting Nations Safe Drivers, the benefits provided may be limited. To ensure the full benefit you should always contact Nations Safe Driver at the phone number provided on the roadside assistance ID card.

Emergency Road Service Consists Of:

Mechanical First Aid – ANY SERVICE REQUIRING A MINOR ADJUSTMENT (exclusive of parts) to enable a disabled vehicle to proceed under its own power.

Tire Service – The changing of a flat tire with a member provided, good inflatable spare.

Battery Service – Attempting to start a vehicle with a booster battery.

Delivery Service – Delivery of an emergency supply of gasoline, oil or water and other accessories and supplies as may be required and available. Cost of materials delivered shall be paid by the member and payment is expected at the time service is rendered.

B. Towing Service: When a vehicle cannot be started, or is unsafe to operate it may be towed to the nearest destination qualified to make repairs on your vehicle.

C. Lockout Service: We will assist you in gaining entry to your locked vehicle in the event the keys are lost or locked inside.

D. Map Service: Your membership allows you to request and receive specially prepared maps for travel. To obtain personalized trip routes and information call 866-294-0934 M-F 9:00am to 5:00pm EST at least two weeks in advance to ensure timely delivery.

E. Theft Reward: The Blue Sky RV Motor Club will pay a person (excluding member's family or relatives) \$500 for information leading to the arrest and conviction of a person for the theft of a member's vehicle or tagged valuable articles.

F. Cancellation: You may cancel your membership at any time in writing. If membership is canceled a refund will be paid to the purchaser, calculated on a pro-rata basis for the unexpired portion.

G. Territory: Services are available throughout the 50 United States, Puerto Rico and Canada.
